Dear Gethin,

I can see no reason why T6 and T7 can be removed. These trees are not in particularly good condition and suffering the effects of historic root compaction. Should you require the felling of these trees, please replace elsewhere on site as mitigation with the following:

- 2 x Wild Service Tree – Standards 120-140cm, stakes and shelters – in accordance with BS: 3998/2010.
- 2 x Field maple – Standards, 80-100cm, stakes and shelters, 303 provenance - in accordance with BS: 3998/2010.

Please use this e-mail as a subsequent addendum to the report. Trees can be sourced from Preeth Heath Forest Nurseries or Mailor Forest Nurseries – Whitchurch. Containerized stock to be used between March and October – bare root stock from October to march.

Any questions please feel free to contact me. If you require any suggestions of contractors please contact me.

We're the architects working on the Ysgol y Garnedd scheme. Thanks for the survey you've previously provided, it's very useful.

We were hoping that you could give us some guidance as two of the trees down to be retained (T6 and T7) impact the access road into the site (see attached the site layout). We've looked at different road layout that will comply with the required standards but these two trees are so close to the site access it's difficult to get anything past these trees without impacting on their route protection areas. Would it be possible to remove these two trees and provide replacement planting elsewhere?
